To further limit exposure with both staff and the public, the following services will be available through mail and online only beginning at five p.m., April 8<sup>th</sup>, 2020.


The following items will be available to you:

1. You can visit the State of Montana website and **renew your registration** at <https://app.mt.gov/vrr>. We can also assist you in renewing your motor vehicle registrations via telephone or you may mail in your renewal card with a check and we can accommodate you. Please remember to add the postage shown on the renewal card.
2. We will do our best to assist with any titling transactions you may need. Titles will be handled on a case-by-case basis.

**Customer with paperwork in-hand:**

  - Mail all necessary documents and completed title paperwork to Sheridan County Treasurer, 100 W Laurel Ave, Plentywood, MT 59254 and include a reliable phone number where we can reach you for payment.

  - For temporary permits please call the office 406-765-3414.

3. We will take **tax payments** by phone with a credit card (fee), an e-check (no fee), or we can give you a payoff date on which you can immediately mail a check and it will be honored without further interest if it is delinquent. You may also process your payment on the county web page if you choose. If any penalty or interest due, please call for the correct amount first.
